

# APPENDIX A

## **Goals of SoSalsa**

The salsa student community has emerged from the interest for salsa and all that is related to salsa. The goals of SoSalsa are as follows:

- To make the existing community visible for (new) salsa students.
- To maintain the continuity of the salsa community: new salsa students will be welcomed in and acquainted to the world of salsa by fellow students.
- To ensure students of all levels get to know each other (by installing horizontal and vertical connections) to remove possible fear of dancing with a higher level student.
- To contribute by means of salsa and other activities to personal development.

## **Activities at SoSalsa**

SoSalsa has the ambition to offer all sorts of activities to its members. Below you will find the activities which are offered in the short term. As the association grows, new activities will be added. The creation of new activities is not merely a job for the board, rather all members are invited and encouraged to think along and take initiative.

- SoSalsa borrels; SoSalsa members get acquainted without being intimidated by each other's level, all with a drink in one hand.
- SoSalsa parties; Parties at which everyone can dance together, and at which dance levels do not concern one another. Members of SoSalsa always get in for free at SoSalsa parties.
- Together we visit other parties in the region. Every week you can choose from a number of parties given anywhere in the Netherlands. Members will be notified about and invited to visit a party.
- Workshops for members of all different levels. External teachers will be invited to give workshops in salsa and other Latin American dances.

## **Membership fee**

TU-student (BSc., MSc.)	€ 25,00 per half year (€ 50,00 yearly)
Other	€ 35,00 per half year (€ 70,00 yearly)

The membership fee will be collected once every half year. Your membership will automatically be extended unless you cancel your membership at least one full calendar month prior to the end of your membership period.

First half year: 1 September to 28 February

Second half year: 1 March to 31 August

## **Membership and minimum TU affiliated**

TU Delft, as our main sponsor, requires a minimum percentage of TU-students or –employees. SoSalsa decided to keep a percentage of 80% TU-affiliated members. If at the moment of your subscription we are under this limit, we will place your application on our waiting list. As soon as we are over the 80% of TU-affiliated, we will contact you.

## **Things you can do now**

- Register for salsa classes, either at the TU Delft Cultural Centre or at an external dancing school. It is also possible to take lessons from Jan & Vivian (salsastudents.nl) with a 5 euro discount as a SoSalsa member.
- Go dancing!

## APPENDIX B

### **Terms of Agreement concerning the Membership fee**

**Term 1:** The member pays at least one half-yearly membership fee.

**Term 2:** The amount of the membership fee is determined by the relation the member has to the Delft University of Technology. Check Appendix A.

**Term 3:** The member agrees to pay at least one membership term by signing the contract. Membership starts when the contract is enforced with a signature of one of the board members. If this is not the case, the member will not be able to participate in SoSalsa activities and will not apply for discounts on entry fees to SoSalsa parties. Also, the member will not be informed of such activities.

**Term 4:** The member will be notified when the membership fee will be collected.

**Term 5:** Disagreement about the collected membership fee must be communicated to the treasurer of SoSalsa within seven days.

**Term 6:** In order to apply for either a back transfer of the membership fee or a rectification of the collected membership fee, the member must have satisfied Term 5 and it must be shown that there is a proper reason to have the collected membership fee transferred back or receive a rectification.

**Term 7:** The collection of the membership fee will occur once every membership period via electronic banking. Exceptions to the method of payment can be made if electronic banking is impossible.

**Term 8:** The collection of the membership fee will recur every subsequent membership period unless the member notifies SoSalsa about ending his/her membership in advance.

**Term 9:** A request for ending the membership is to be submitted in written form at least one whole calendar month before the end of the membership period, supplied with personal data of the member and the reason for ending the membership.

**Term 10:** If the member with request to end the membership does not satisfy Term 9, then Term 8 will be applied.

**Term 11:** The yearly increase of the membership fee will be announced at the 'ALV'. After approval by the ALV, this increase will not be open for debate any longer.

**Term 12:** The member is obligated to acknowledge the aforementioned Terms 1 - 12.
